KUMTOR ISSUES 1M USD FOR MICRO-CREDITING DEVELOPMENT IN ISSYK-KUL PROVINCE

The Kumtor Gold Company CJSC (Kumtor) transferred 500 K USD to micro-credit agencies 'Jeti-Oguz', 'Ton Finance' and 'Balykchi Finance' to support the microcrediting programs of Issyk-Kul Province, and 500 K USD will be transferred in July of 2013 as well.

Being aware of the importance of the creation of conditions for social and economic development of Issyk-Kul Province, Kumtor has been implementing the micro-crediting program in Issyk-Kul Province since 2006. Three micro-crediting agencies were organized through the support of Kumtor. They provide the micro credit loans, from 10% to 12% interest rate which is the lowest in Kyrgyzstan. Thanks to this, the residents of Jeti-Oguz and Ton Districts, and Balykchi town get access to funds for development of stock-raising, farm enterprises, and small and medium business. Since 2006, Kumtor has invested more than 2 M USD in the micro-crediting program. Taking into account additional financing, the total investment will be 3,160 M USD to the end of 2013.

«We know that the population of the I ssyk-Kul Province require the funds provided by the micro-credit organizations. and therefore we decided that additional funding of the micro-credit organizations in the province would assist in improving the economic outlook. The funds would provide the people with the ability to develop their own businesses and thus, promote growth in the prosperity of people, the development of the various communities, and the economic expansion of the province» Michael Fischer. the President of the Kumtor Operating Company



Kumtor has established solar panels at Ton and Kok-Sai, Ton district, thus making running water available to more than 1,000 residents.

In these photovoltaic panels solar energy is converted into electrical and provides the water pumps, supplying water from underground wells to the village. If before the villagers had an access to the water only for an hour a day, now thanks to panels, it is available around the clock. Highly efficient solar panels work in a sunny and in cloudy weather conditions. These panels are able to accumulate energy and provide water even at night.

Solar pump is easy in use and is designed for 20 years of service. In total Kumtor Company allocated 529,000 soms to install 8-panel solar system in Mys Valley of Ton village and 857,000 soms to install 16-panel solar system in Kok-Sai village. Investments in modern technology will not only improve the quality of life of the villagers, but also will help the local government to make significant savings on electricity bills.

KUMTOR COMPANY AND AVEP PUBLIC FOUNDATION IMPLEMENT THEIR JOINT PROJECT

The Kumtor Company and AVEP Public Foundation implement their joint three-year project, Karagat+, designed to give a boost to communities and expand the potential of the fruit-and-berry market in Kyrgyzstan.

The Project area will be the Issyk-Kul region, the southern coast of Lake Issyk-Kul in particular. Under this environmentally oriented Project, the Foundation will be training the farmers in the field of growing new varieties of currants, high-yield and cold- and disease-resistant, and innovative irrigation methods. AVEP experts will also provide assistance in creating a network of nursery gardens and farming goods reception centers.

Under the Project, special attention will be given to raising the farmers' awareness of marketing fundamentals to enable them to act unassisted in establishing distribution facilities and making berrygrowing business more profitable. AVEP undertakes to help farmers as early as this year in their efforts to market their produce. Following the selection and training of farmers this non-governmental organization is supposed to start assembling the drip irrigation system in the plots allotted.

"This Project's key advantage is that it allows for a comprehensive approach to berry-growing. The Foundation will be assisting the farmers all the way through: from the purchase and distribution of seedlings to the sale and processing of the finished produce. It is also of great importance that the Project will have a good effect on the environment as currants bush roots will stabilize hill sides and thus minimize soil erosion," said AVEP Director, Maksat Abdykaparov.

«We are happy that this Project is going to be implemented, with our support, in the Issyk-Kul region. Hopefully, this Project will increase the farmers' incomes and promote innovative farming methods throughout the region,» Michael Fisher.

Due to lack of fuel across the region, KOC provided 118,030 liters of diesel fuel to local farmers at a reduced price of 33 soms per liter. Taxes had been prepaid by the Company itself. Expenses borne by the Company for the fuel were **684,572 soms**

Financial aid to Ton district through the Issyk-Kul Region Development Fund was 57,308,388 soms.

IN ADDITION:

The two-year project being implemented by One Village One Product Association (OVOP) in Ton district has involved 20 communities located in the villages of Kaji-Sai, Bokonbayevo, Temirkanat, Ai-Sai, Shorbulak, Kyzyl-Tuu, Tort-Kul and Koi-Moinok, largely engaged in the production of jams, cheese, juices, and felt goods. Apart from receiving training, Ton residents were also enabled to display their goods in Karakol and Bishkek research shops, where participants, if necessary, could also acquire marketing and business skills. Total for Issyk-Kul Province: US \$300,000.

The project implemented jointly with FTU: computer skills and vocational guidance for 9-11-grade students in 10 pilot schools in Issyk-Kul province, including 5 schools in Ton district (the villages of Korgondu-Bulak, Toguz-Bulak, Kara-Taala, Ak-Olen, and Ala-Bash). Computer classes provide basic skills in Word, Excel, PowerPoint and enable students to deal with key economic problems.

The life skills training consists of two stages: general information and advice regarding choice of profession

In 2013, Kumtor provided 119 800 liters of diesel fuel to local farmers at a reduced price of 34.5 soms per liter. Taxes were prepaid by the Company itself. As of end of May, the Ton District Administration had received 129,278 liters. Expenses borne by the Company for the fuel were **387,835 soms**.

Financial aid to Ton district through the Issyk-Kul Region Development Fund has so far amounted to **8,050,000 soms**

and basic qualifications received by students at the first stage. The second stage embraces information on the employer's criteria and demands. The students will acquire basic skills in writing a resume or motivation letter, and taking an interview.

One bank has been founded at Bokonbayevo as part of the Youth Banks Project, which is being implemented in collaboration with Eurasia Foundation of Central Asia. The total Kumtor-paid budget of the Project is US \$300,000, or US \$50,000 per bank.
